Awards

Awards Committee – Jim Sumner, Chair

In January of 2023, at the request of Scott Robinson, I took the role of Chair of the Awards Committee. The committee members also include Dean Heckel and Dave Pernai. As always, we welcome anyone who wishes to assist us in this important association effort, namely the tangible support and recognition of the Midshipmen of the University of Wisconsin, Naval Reserve Officer Training Corp.

Accomplishments

Before I assumed the chair of the committee, Scott Robinson and the Unit Staff created an innovative collection of the annual awards that the Alumni Association participates in as either a direct sponsor or as a steward of an award sponsored by a family or foundation through the Alumni Association. These awards were compiled into individual award profile sheets with their own criteria and details, as well as a graphic matrix to illustrate the annual recognition that the association engages. Awards Program Administration

In addition to supporting these speaker engagements, the Association is working with the Unit on administrative aspects of the Awards Program. This work with the sponsors has ensured that all awards, both sponsored and supported by the Association, have clear criteria to assist in the Commanding Officer's nomination process. The Association and Unit have also sent a letter to legacy sponsors proposing the Association become the principal point of contact in the awards process.

Battalion Support

Financial Support

The Battalion has access to an approximate \$4,000 "line of credit" to make purchases on recreational gear to enhance the camaraderie among the students. This amount represents the available amount from the \$5,000 gift provided by the Association in October 2022. Access to this line of credit provides the Battalion flexibility on purchases to enhance their quality of life.

Communications Committee – Phil Midland, Chair

Under the leadership of Phil Midland, the Association continues the Voices of Experience Program.

The Voices of Experience (VoE) Program aims to expose the Battalion to macro-level perspectives on Naval Service, National Security, and geopolitics from General, Flag, and other senior officers.

This Spring we were honored to have hosted the former Secretary of the Navy, the Honorable John Lehman for a Zoom presentation and Q&A.

VoE talks are scheduled for 60-90 minutes and consist of a speaker presentation followed by a Q&A session. We are in the process of scheduling appropriate speakers during this current academic year.

The Battalion did not utilize a second series of speakers under the “Fleet Nugget Series” in the past year. The Association would like to thank all alumni contacted and volunteered to speak. We will tee up the idea of the program for the Battalion to draw upon this coming year.

Unit Support

At present we support the Unit in the execution of commissioning ceremonies, coordinating speakers, through the Unit, for the Battalion, and in the administrative aspects of the Awards Program. The Association would like to thank Captain Barnett and his staff for supporting the Association for the Reunion Weekend and a myriad of other areas where our missions are mutually supportive.

Commissioning Ceremony Support

We provided professional books, “Newly Commissioned Naval Officer’s Guide” and “The United States Marines: A History”, and three years of NROTC Alumni Association membership to the newly commissioned officers. Alumni Engagement

Our alumni engagement activities include social events, outreach through the Badger Shipmate newsletter and emails, membership and fundraising drives, and our website. None of this happens without a sound financial foundation.

Social Events

The Annual Reunion on 27 and 28 October had 53 attendees for the Friday evening social with the Battalion and 37 for the Pre-Game Tailgate. We were unable to offer discounted block seating for the game against Ohio State. Earlier in the year, following our Winter Board of Directors meeting, we held a mid-winter meetup on February 3, 2023, at Jordan's Big 10 Pub (unofficial pub of the Association).

Badger Shipmate – John Washbush, Editor

The 2023 edition of Badger Shipmate was prepared, using the basic format developed in 2022, printed and mailed to 1263 alumni and former staff in July. As before a strong emphasis was placed on personal updates/articles from alums, significant events within the UW NROTC Unit, and awards sponsored by and through the Alumni Association. Given that the total cost for printing and mailing is approximately \$2600, the board is considering examining the value and cost-effectiveness of this large expenditure. Electronic means exist for publishing and distributing the newsletter at little if any incremental cost.

Mailchimp, Website and Facebook

We rely on our email platform, our website, and Facebook to get the word out! We strive to ensure we are not inundating you with emails but still provide you with the information you need. We posted several emails over the past year to keep you updated on Battalion activities, commissioning ceremonies, social events, Board meetings, Voices of Experience speakers, Bylaws updates for member approval, and Director voting. We find it a great tool to facilitate getting the word out.



Membership

Our membership increased again this past year. As this report was prepared, the Association had **267** members, an increase of 16 members (6% growth) from last year's 251-member count. This membership was made up of the following membership terms:

- 134 Life Members: (8 new in the past year)
- 81 Five Year Members: (8 new in the past year)
- 39 Midshipman Three-Year (6 new in the past year)
- 13 One-Year Members: (9 new members or renewals).
- Numbers may not sum directly as some five-year members become life members.

Association Operations

The Board of Directors usually meets four times a year. The Executive Committee (President, Vice President, Secretary, and Treasurer) usually meets once between Board meetings and coordinates activities of the committees while conducting routine business.

Significant Decisions October 2022 – September 2023

The following decisions were made by the UW Naval ROTC Alumni Association Board (the Board) or Executive Committee (EXCOMM) during the period of 1 October 2022 – 30 September 2023.

1. The Board decided to offer membership to a donor based on the donation given (if they are not already a current member). President Robinson took action to offer membership in thank-you letters; Emeritus Director Ackerbauer took action to update membership list accordingly.
2. Established by charter in September 2022, the Strategic Planning Committee provided the board with a status of their efforts. The foundation of their work was the development of a new mission and vision for the organization. The Board approved the following provisional vision and mission statements to facilitate continued strategic planning work: *Vision - Bonding the Badger Battalion alums. Mission – Strengthen camaraderie among UW NROTC alums and champion the Unit staff and students.* The Strategic Planning Committee took action to ensure a final, Board-approved vision and mission statement will be provided to the membership for final approval.
3. Vice President DiMaggio reported an initiative that teams SeaBadger attire with Land's End. Lands' End Business allows individuals to purchase items with their logo added. Individuals must create their own account, add the SeaBadger logo to their profile, and order their items. The association would need to set up a Lands' End Business account, have Lands' End create our logo (cost ~ \$89), and "advertise" to our alumni. The Board approved the setup of a Lands End Business "storefront" and advertised this info to alums for the purchase of SeaBadger attire.

4. The Board approved a revised FY2023 budget and adopted a provisional set of financial guidelines to evaluate in practice and consider for future inclusion into the Association Bylaws. The following guidelines include but are not limited to:
 - The Fiscal Year will run from 1 September to 31 August of the following year.
 - The budget will separate Restricted (Awards and financial aid funds) from Unrestricted (Operating) funds.
 - The budget will be developed with a zero net operating objective. Anticipated revenues will equal planned expenditures for both restricted and unrestricted funds.
 - All budgeted expenditures reflect a plan for spending, not a requirement.
 - The budget will be approved by the Board of Directors prior to the start of the fiscal year.
 - Any unplanned or emergent spending exceeding \$100, or projected shortfall of revenues exceeding twenty percent of the budgeted amount, shall be reported to the entire Board of Directors by email when known or anticipated by any Director. The EXCOMM will review the issue and recommend a course of action for approval by the Board. The EXCOMM may approve expenditures of \$100 or less.
5. D&O insurance protects the directors and officers from personal liability for allegations of misconduct committed while in service to the association and covers defense costs, settlements, and judgments arising from allegations of misconduct. While we have some limited liability coverage in state law Wisconsin Stat. 181.0855 & 181.0670 if sued (frivolous or otherwise) it would fall to our individual selves to fund. The Board approved the purchase of D&O insurance from Great America (at \$536) via HUB International. Vice President DiMaggio completed the purchase of insurance including 'No Known Issues' letter. D&O insurance was bound with Great American effective 05.01.23 via Hub. It was placed on a direct bill, an annual pay payment plan.
6. The Dishonesty Bond for all Board Officers was due for renewal on 11 July 2023. It was provided by CNA Surety and its subsidiary Western Surety Company. We held a \$50,000 bond at a cost of \$257 annually. The EXCOMM decided to shift to the crime policy provided by Great American (who provides our new D&O insurance). This policy covers both Officers and Directors and provides broader coverage including employee dishonesty, forgery/alteration, computer fraud, fund transfer fraud and more. It costs \$266 annually.
7. The Board decided that association membership shall be entered on a calendar-year basis. The annual dues shall be payable in advance by 31 December. Members in arrears will be deemed inactive and ineligible for membership benefits. New leadership shall implement this bylaw change post-election of new Board Directors and new Alumni Association Officers.
8. The Board approved the proposed budget for the 1 September 2023 - 31 August 2024 budget year.

9. The Board approved an updated Mission statement and the establishment of a vision that was developed and recommended by the Strategic Plan Special Committee:
- **Mission:** Strengthen camaraderie among UW Naval ROTC alums and support the Badger Battalion.
 - **Vision:** Bonding the Badger Battalion – past, present, future.

Several of the Board decisions above will be reflected in proposed changes to the Bylaws that will be presented to the membership for review and approval at a future date. 36 Year

Bylaws Update

No membership-approved changes were made to the Bylaws in the past year. The current Bylaws, dated 15 September 2022, can be found on the Association website. The Board voted to amend the membership language in the next update of the Bylaws and discussed new language concerning the financial management of the operating budget. Along with the revised mission statement and new vision, these issues will be written into the next update of the Bylaws and then proposed to the membership for approval in the coming months.

Fundraising Committee – Paul Gilmartin, Chair

For the 2022 to 2023 operating year (October 2022 through August 31, 2023), the Fundraising Committee set a goal of \$20,000 in donations. Funds raised include \$3,525 in membership dues payments, \$8,047 in general donations, and \$14,700 in awards funds donations, for a total of \$26,272.

Thank you to our Award donors for their contributions to award scholarships. They have been keeping alive a historical and critically important mission of the NROTC Alumni Association to recognize those Midshipman Battalion students who have exceeded expectations. A special thank you to Bill Kirkpatrick, James Carpenter, Suzanne Redenius, Mark Pankow, and Philip Palmer for their very special contributions.

Additional thanks go out to other donors who support the NROTC Alumni Association with unrestricted donations to support the Midshipman Battalion line of credit and other Alumni Association efforts. Thank you to Jerry Hicks, Philip Palmer, Scott Robinson, Bill Radtke, John Washbush, Kris Ackerbauer, Joe Abel, Tank Murdoch, Kenneth Green, Jeff Johnson, Sara Zenobian, and one anonymous donor.

Insurance Coverage

As noted under Significant Decisions, the Board voted to add Director and Officer Liability Insurance with Great American Insurance this past year. The annual premium will be in the \$500 - \$600 range. This coverage will provide insurance for each Director in the case of a lawsuit. The D&O insurance policy augments our existing Dishonesty Bond (protection for financial malfeasance).

Treasurer Updates – Sara Zenobian, Treasurer

Operating Account Balances

The Association has a money market account at UW Credit Union to take care of operating expenses and to receive funds from *unrestricted* donations, membership dues payments, social events and football game ticket sales, etc. All *restricted* donations are first deposited to this account before transfer to the trust fund.

Gift Fund Balances

The Association places restricted donations into the General Fund account administered by the UW Office of Trust Funds. This account distributes funds to supported and sponsored awards, including the Arnold, Dinauer, Pulver, Freshman Spirit, Lyman, and Lueder awards. In 2021 a separate account was established with a \$100,000 donation by Ross Annable. The Annable Fund account supports payments for the Alf and the new Billipp awards and is completely separate from the General Fund. These funds are managed by the Office of Trust Funds and the losses shown below reflect market conditions.
